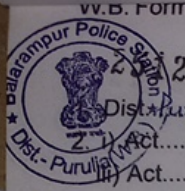

Sub: Lodging F.I.R against Sri Shibdurga Majhi, S/o. Lt. Surendranath Majhi for unauthorized use of Electricity by way of hooking u/s 135(i)(a) of Electricity Act 2003 (Amended in 2007).

Sir,

I Sri Sisir Kumar Das, S/O- Banamali Das, A.E & Station Manager of Balarampur CCC of WBSEDCL do hereby lodge complaint against Sri Shibdurga Majhi, S/o. Lt. Surendranath Majhi resides at Vill - Kadamdih, Po. Bara Urma, PS : Balarampur, Dist. Purulia to the effect that received an information, that the aforesaid accused person was committing theft of Electricity in his residence by way of direct hooking from the LTOH Line of WBSEDCL.

Acting upon such information on 28.01.2022 from 01.05 PM to 01.15 PM I, along with Sri Manab Kr. Maji, J.E. Gr-II, Sri Arindam Chatterjee, Sr. O.E Balarampur CCC and technical persons of M/s. Niharika Electric Works (Enlisted Agency of WBSEDCL) inspected the premises of Sri Shibdurga Majhi and held raid.

During raid and inspection it was detected that accused Sri Shibdurga Majhi was using electricity dishonestly by making direct hooking from the nearby LTOH Line of WBSEDCL for running 2 No. 60 Watt Lamp having connected load 0.12 KW.

I prepared Inspection report in presence of the representative of the Accused and assessed the Load as 0.12 Kw. Details have been mentioned in the Inspection Report and the representative of the accused refused to sign on it.

I directed Sri Sanjoy Mahanty, Skilled Labour of M/s. Niharika Electric Works (Enlisted Agency of WBSEDCL) to disconnect the hooking line/ arrangement from our LTOH line. Accordingly he disconnected the aforesaid hooking line/arrangement from LTOH Line.

I prepared seizure list in presence of the representative of the accused & witnesses, details of seizure have been mentioned in the seizure list and the representative of the accused refused to sign on it. A copy of the seizure list was handed over to the accused. The Local people gathered there witnessed the incident but refused to sign on the Seizure list and inspection report.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence u/s 135(i)(a) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
