The humble petition on behalf of the above-named Petitioner/complainant

Most respectfully sheweth:-

1...That the Complainant's matrimonial house is Village-Dhadanga, P.O. Nischintapur, P.S. Barabazar, District Purulia and now residing at her father's house at Village-Danda, P.O. Simulia, P.S. Tamna, District Purulia .

2...That on 16.05.2012 according to Muslim rites and customs prevailing in their society married the complainant accused No. 1) Jumrati Momin . At that time the complainant's father fulfilled all demands , of the accused persons ., like dowary of Rs.45,000/- (Rupees Forty five thousand) and gifted articles .

3..That after their wed lock, the complainant gave birth a female child and both of them the Complainant and accused no. 1 named the baby Aksara Khatoon.

4...That the Complainant was tortured by her matrimonial house members like her husband Jumrati Momin , father-in-law, Babujan Momin, and Mother-in-law Joygun Bibi after her marriage, but she bear all such insult of her matrimonial house members/ because she had no way, but day by day the tortured was so increased. So, in the month of September 2020 she lodged a Complain ~~case~~ before Barabazar Police Station and Barabazar Police Station treat the same as a F.I.R.U/S 498A, and the accused persons obtained bail from the Honourable Court.

5...That on 20.12.2021 accused no.1 Jumrati Momin came to the father's house of the Complainant and approached her parents that he want to take back the complainant and minor baby at her matrimonial house. So, the parents of complainant gave consent to this decision and with the consent of parent's the complainant i.e. Tyafur Eibi went to her matrimonial house.

6..That on the same day at night accused no.1 the husband, accused no.2, the father-in-law and accused no.3 mother-in-law throw Kerosine oil over body of the complainant and caught fire but some how the complainant is sought for help and with the help of local people she would be able to escaped from the matrimonial house .

7..That the complainant has informed this matter to Barabazar Police Station as well as Superintendent of Police Purulia but till today she got no relief from there. So, she is liable to take shelter before the Ld. Court of law for justice.

It is respectfully prayed that your Honour would be please to accept the petition U/s 156(3) Cr.P.C. and directed to Barabazar Police Station to treat the same as a F.I.R. and be please to pass necessary order.
