We requested them with various manner but some villagers including Ladies did not pay heed of our words and showing adamant behavior, I requested them to help us to execute the order dt 07/01/2022 of Chairperson, Child welfare committee, Purulia District vide Memo No-14/CWC/PRL/2022 but by the influence of villagers the above noted persons not to agree to hand over the child and local people strongly oppose and obstructed us to execute the order. There is every chance to create L/O problem and untoward incident as well as assault to police can't be ruled out

Under the above facts and circumstances, finding no other alternative way we return back to PS and submitted a written complaint against i)Paru Mahato W/o Lt Sudhir Mahato ii) Kailash Mahato S/o Lt Jotilal Mahato iii) Ranglal Mahato S/o Lt Ghasiram Mahato and iv) Haripada Mahato S/o Basanta Mahato & 15/20 others including ladies all of Vill- Natundih PS-Barabazar Dist-Purulia for disobedience to promulgate the order of Ld CWC Purulia by creating obstruction.
