Sir,



Moreover, all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. 5. Mahendra Mahato (36) S/O- Muchiram Mahato of Vill- Talpat, PS - Bandwan, Dist- Purulia.


Hence it is prayed before you that a specific case may kindly be lodged against the above mentioned persons under proper section of law.
