Most respectfully begs to state :-

1. That the petitioner is permanent resident of Village-Dholkata within P.S.- Hura, and within the jurisdiction of this Ld. Court at Purulia.
2. That the petitioner has his cultivable land in Mouza-Pirrah.
3. That like previous years the petitioner ploughed his land and grow paddy in the said land.
4. That the petitioner used to look after the paddy crops everyday in the morning.
5. That on 09/12/2021 in the morning at about 5.00 A.M. the petitioner went to his paddy land and ~~was~~ saw the accused persons and some other persons names not known but can identify their face if they be produced before the petitioner were cut all the paddy and loaded those paddy over three bullock carts. The accused persons were about to leave the place but the petitioner raised protest about such theft. At that time the accused persons pushed your petitioner and the petitioner fell down. The accused persons assaulted the petitioner and threatened with dire consequences.
6. That the petitioner sustained monetary loss of Rs. 22,000/- (Rupees twenty two thousand) only for such theft of paddy.
7. That the petitioner informed the incident to the officer-in-Charge Hura Police Station on 09/12/2021 but as the police did not take any quick step against the accused persons, the petitioner again sent his complaint through
