Sir,

In producing herewith the arrested accused persons namely (1) Chitta Mandal (50) S/O Lt. Prankrishna Mandal of Vill-Iloo, PS- Jhalda, Dist- Purulia (2) Sanat Mahato (44) S/O Lt. Thakurdas Mahato of Vill-Het Jargo, PS- Jhalda, Dist- Purulia (3) Chandai Charan Mahato (62) S/O Lt. Madhusudan Mahato of Vill-Chandai, PS- Jhalda, Dist- Purulia (4) Kartick Mahto (51) S/O Lt. Sripada Mahto of Lagam, PS- Silli, Dist- Ranchi, Jharkhand before you, along with seized articles like (i) Board money amounting to RS- 50,700/- (ii) 02 seal Pkt. of Playing Card (iii) 41 pieces of Playing cards (iv) Approx 5 fit/4 fit white colour plastic sheet as per seizure list from a common gaming house i.e. the house of Lalu @ Digambar Mahato S/O- Lt. Joggeswar Mahato of Vill-Jargo, P.S- Jhalda, Dist.- Purulia which is equipped with the sufficient light of electricity.

I, S.I Milon Manna along with (1) C/694-Gorapada Pal (2)C/1484-Kajal Kr. Nayak (3) HG/1681-Mannatha Kumar was performing the Evening Mobile duty vide C.C No- 09/2021 in consonance with the Jhalda PS GDE No-26 dated 1/1/2021. During my evening mobile duty, I received a tip of that one gambling with huge amount was going on at the house of Lalu @ Digambar Mahato at Jargo village under Jhalda PS. Subsequently, I informed to you and the duty officer to diarise the matter vide Jhalda PS G.D.E No- 34 Dtd- 01/01/22. Accordingly, as per your order, I along with force left for the house of Lalu Mahato at Jargo village under Jhalda PS to work out the information by govern vehicle. At about 20:25 hrs, we reached yonder to the house of Lalu @ Digambar Mahato at Jargo village and leaving the vehicle, on foot very slowly and cautiously approached towards the house of Lalu @ Digambar Mahato where the gambling was reportedly going on and arrived at the house at about 20:35 hrs. From the outside of said house, we heard the talking of persons present there and within a few moment it was clear that the persons present there were continuing gaming with playing cards in exchange of money causing wrongful loss to one and wrongful gain to another. After that, I asked my associate staffs to cordon the place and within a moment the place was cordoned by Police party. We disclosed our identity and requested them to search myself and my other staff accordingly the persons searched ourselves and found nothing except wearing apparels and Mobile Phones. After that we asked their identity and the persons disclosed their names and addresses as noted above. It was found that a huge amount of currency note of different denomination were kept on gaming board i.e. one White plastic placed on the floor and the room of the common gaming house was equipped with sufficient light of electricity and the playing cards were also found. On demand the persons clearly confessed that all of them were doing gambling with playing cards in exchange of money for wrongful loss to one and wrongful gain to another. We searched for the public witnesses but none was available. Subsequently, I seized the following articles such as (i) Board money amounting to RS- 50,700/- (ii) 02 seal Pkt. of Playing Card (iii) 41 pieces of Playing card (iv) Approx 5 fit/4 fit white colour plastic sheet from the common gaming board after preparing proper seizure list duly signed by the above noted accused persons in presence of the available witnesses in between the 20:45 hrs - 21:25 hrs. and sealed and leveled in presence of witnesses and the accused persons. The copy of seizure list was supplied to the accused persons.

As the above noted accused persons committed offence punishable u/s- 3 & 4 of West Bengal Gambling and Prize Competition Act, 1957, so I arrested them at 21:30 hrs after informing them the ground of arrest and issued memo of Arrest in respect of each of the above persons.

From the statement of accused persons it was clear that the gaming was going on under guidance and full of knowledge of the said house owner namely Lalu @ Digambar Mahato S/O- Lt. Joggeswar Mahato of Vill-Jargo, P.S- Jhalda, Dist- Purulia.

Therefore I pray before you that one specific case may kindly be start under proper section of law against the above noted accused persons along with the house owner namely Lalu @ Digambar Mahato S/O- Lt. Joggeswar Mahato of Vill-Jargo, P.S- Jhalda, Dist- Purulia and arrange its investigation.
