Consequently, it reasoned to believe that they violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 753-ISS/2M-22/2020 dtd 14/06/2021 in consonance with order promulgated by Govt. of West Bengal vide Memo No 486-CS/2021 dtd 24/04/2021 following with the order of Govt. of West Bengal vide Memo No-647-ISS/2M-22/2020 dtd 15/05/2021, Memo No 753/II-ISS/2M-22/20 dtd. 28.06.21 and Memo No 753/III-ISS/2M-22/2020 dtd. 14.07.21 and Memo No-753/IV-ISS/2M-22/2021 dtd-29/07/2021 & Memo No- -753/V-ISS/2M-22/2020 dated-13/08/2021 & Memo No- 753/XVI-ISS/2M-22/2020 dtd-02/01/2022 & Memo No- 753/XX-ISS/2M-22/2020 dtd-15/01/2022. Consequently, the supra noted persons were arrested on the spot from 16:35 hrs to 17:10 hrsand informed them about the ground of their arrest and issued memo of arrest in respect of them.

As the supra noted persons violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 753-ISS/2M-22/2020 dtd 14/06/2021 in consonance with order promulgated by Govt. of West Bengal vide Memo No 486-CS/2021 dtd 24/04/2021 following with the order of Govt. of West Bengal vide Memo No-647-ISS/2M-22/2020 dtd 15/05/2021, Memo No 753/II-ISS/2M-22/20 dtd. 28.06.21 and Memo No 753/III-ISS/2M-22/2020 dtd. 14.07.21 and Memo No-753/IV-ISS/2M-22/2021 dtd-29/07/2021 & Memo No- -753/V-ISS/2M-22/2020 dated-13/08/2021 & Memo No- 753/XVI-ISS/2M-22/2020 dtd-02/01/2022 & Memo No- 753/XX-ISS/2M-22/2020 dtd-15/01/2022.
