In producing herewith 03 (Three) arrested accused persons namely 1. Sanjoy Mahato (38) S/O Gouranga Mahato of Vill.- Akura, PO-Tulin, PS-Jhalda, Dist.- Purulia 2. Saraj Mahato (42) S/O Lt. Brajamohan Mahato of Vill-Banddih, PO-Mosina, PS-Jhalda, Dist.- Purulia 3. Anadi Mahato (31) S/O Lakshman Mahato of Vill-Shyamalpur, PO-Nowahatu, PS-Kotshila, Dist.- Purulia under arrest along with seized articles as per seizer list i.e. (i) 05 (Five) Ltrs. ID Liquor (Cholai) in a Plastic Jarican (ii) 20 pieces of plastic glass under proper seizure with label.

I SI Sujat Das of Jhalda PS hereby lodged a written complaint against the above noted accused person to the effect that today (24/01/2022) myself along with C/696-Gorapada Pal, NVF/1036-Parmatha Kuiry all of Jhalda PS were performing anti crime special mobile duty (This refers to Jhalda PS CC No. 233/22 dated 24/01/2022 and GDE No. 954 dated 24/01/2022. During special mobile duty at about 17:15 hrs I received a credible source information that the above noted accused persons was selling ID Liquor (Cholai) illegally at open field near Kansra mela under this PS. On receipt such information I immediately informed the matter to IC of the PS and as per his direction I along with force proceeded to work out the information. At 17:35 hrs we reached at Kansra mela and my source shown the persons from a distance whom were selling the liquors there. We immediately reached there and surrounded them, but other people who were assembled there to purchase liquor, on seeing Police Party managed to flee away from the spot. On searched (i) 05 (Five) Ltrs. ID Liquor (Cholai) in a Plastic Jarican and (ii) 20 pieces of plastic glass were found there. On demand they failed to produce any license / authority of the said liquors. On interrogation they also made incoherent statement regarding possession of said liquors and told that they are usually selling the same to the villagers illegally. So, finding no any other alternative I seized the above noted articles from the possession of the accused persons and labeled, duly singed by the accused persons & witnesses in between 17:55 hrs to 18:35 hrs in which 500 ML of ID Liquor (Cholai) in a bottle from mother sample were kept as sample with label. During interrogation they confessed their guilt as such I arrested them at 18:40 hrs after observing all the formalities as per law issuing memo of arrest as the accused persons is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused persons namely 1. Sanjoy Mahato (38) S/O Gouranga Mahato of Vill.- Akura, PO-Tulin, PS-Jhalda, Dist.- Purulia 2.
