Sir,

In producing herewith the arrested 02 (two) accused persons namely (1) Rupjal Soren (49) S/o Late Raghu Nath Soren village Marlu, PS-Saltora, Dist-Bankura A/p.Dhobipara, Andal More, PS-Andal, Dist-Paschim Burdwan (2) Kalidas Murmu (30) S/o Ganesh Murmu of Gohalbira, PS-Santuri, Dist-Purulia along with seized article i.e. one seized Truck vehicle bearing No. WB-39A/7779 loaded with approx 12 MT of steam coal.

I beg to submit that today (27/01/2022) at 18:55 hrs. myself along with C/04 Akash Kumar, C/696 Gorsapada Pal, HG/1829 Subed Chandra Mahato & HG/1807 Shyam Sing Laya left P.S. for performing anticrime patrolling duty vide GDE No. 1384/22 dt. 27/01/2022 in consonance with Jhalda P.S.C.C. No 264/22 date- 27/01/2022. During the patrolling duty at about 18:50 hrs received a tip off that an unauthorized truck loaded with stolen steam coal was coming from Jharkhand side along Gola road towards Jhalda and would proceed to Purulia. Subsequently, I informed to you and the duty officer and asked him to note down GDE vide No IC56 dated 27.01.2022. Consequently as per your kind order I started Nakas at Brajapur More by placing the guardrail on the Purulia Gola Road. Accordingly, the said truck loaded with stem coal arrived at the Brajapur More at about 19:45 hrs. and I found the said truck loaded with stem coal as identical as I previously received the information. I asked the driver to produce the relevant documents in respect of the vehicle having no WB39/7779 and the loaded stem coal. On searching it was found that the said Truck was loaded with approx 12 {twelve} MT coal. On asking the driver and the helper disclosed their identity as [1] Rupjal Soren (49) S/o Late Raghu Nath Soren village Marlu, PS-Saltora, Dist-Bankura A/p Dhobipara, Andal More, PS-Andal, Dist-Paschim Burdwan (2) Kalidas Murmu (30) S/o Ganesh Murmu of Gohalbira, PS-Santuri, Dist-Purulia respectively but on asking driver of the said Truck failed to produce any papers in respect of said Coal as well as papers in respect of the said Truck. He also made incoherent statement in respect of possession of the Truck vehicle bearing No. WB-39A/7779 loaded with approx 12 MT of steam coal. So, it is reasonable to believe that the driver as well as the helper in cahoots with the owner of the said truck collected the said coal either by theft or by any fraudulent means from anywhere and transporting the same to run clandestine business for wrongful gains with the help of others namely 1) Naresh Gorain 2) Ramesh Mahato 3) Buku @ Bablu Gorain 4) Binod Gorain all of Madhupur PS- Jhalda 5) Narayan Sing of Purabtard , Jharkhand State 6) Labu @ Lelesh Gorain of Brajapur 7) Lalbabu Gorain of Brajapur 8) Tara Dutta of Brajapur 9) Anadi Mahato of Darda 10) Ashok Thander of Mosina More 11) Pradip Saw of Mosina More [SI No 6-11 of Jhalda PS]. On interrogation the driver and helper of the said truck confessed their guilt. As such it is every reason to believe that the driver as well as the helper in cahoots with the owner of the said truck No. WB-39A/7779 and others (as noted above) are transporting the coal illegally. Subsequently, I seized the truck having registration no. WB-39A/7779 loaded with approx 12 {twelve} MT coal under proper seizure list duly signed by the accused driver and the accused helper in presence of the available witnesses. Though, I searched for the public witness but none was available there at that time. Thereafter, I arrested the accused driver as well the accused helper as noted above after informing them the ground of arrest and observing all formalities and issued Memo of arrest against each duly signed by them and arrived at PS with accused persons and the seized articles.

I therefore pray before you that the accused persons namely (1) Rupjal Soren (49) S/o Late Raghu Nath Soren village Marlu, PS-Saltora, Dist-Bankura A/p Dhobipara, Andal More, PS-Andal, Dist-Paschim Burdwan (2) Kalidas Murmu (30) S/o Ganesh Murmu of Gohalbira, PS-Santuri, Dist-Purulia 3) Naresh Gorain 4) Ramesh Mahato 5) Buku @ Bablu Gorain 6) Binod Gorain all of Madhupur PS- Jhalda 7) Narayan Sing of Purabtard , Jharkhand State 8) Labu @ Lelesh Gorain of Brajapur 9) Lalbabu Gorain of Brajapur 10) Tara Dutta of Brajapur 11) Anadi Mahato of Darda 12) Ashok Thander of Mosina More 13) Pradip Saw of Mosina More [SI No 6-13 of Jhalda PS] 14) The owner of the truck having registration no. WB-39A/7779 committed the offence U/8 379/411/413/414/120B of the IPC so they can be booked and arraige for its investigation.
