In producing here with 02(Two) arrested accused person namely Bipin Mahato (29) S/O Dharmaraj Mahato of Vill- Darda, PS- Jhalda, Dist- Purulia and along with 01(one) seized Tractors having reg. No- WB55A 6504 attached with sand loaded trolley (approx 100 cft sand loaded in trolley). The fact in brief is that today (12.21.2022) I along with force namely i) C/04- Abadhut Kumar ii) C/1284-Pratapaditya Majhi iii) NVF/843-Bibek Mahato iv) HG/1636- Harekrishna Ghosh was performing night mobile duty in PS area vide Jhalda P.S. GDE No- 501 Dated- 12/01/2022 in consonance with Jhalda PS CC No- 123/22 Dated- 12/01/2022. During my night mobile duty I received credible source information that one Tractor was lifting & carrying sand illegally and coming from Subarnarekha ghat & coming towards Jhalda Town. Subsequently, I informed you and as per your gracious order, I placed Naka at Mosina more to work out this tip off and started Naka Checking after proper placing guard rail on the road. Thereafter I saw the one Tractor was proceeding towards Mosina more. Consequently, we intercepted the said Tractor at before Naka checking point at about 22:45 hrs and found that the vehicle as well as goods as identical as I received prior information. But seeing the Police Party driver of that vehicle (Tractors) started to flee away. After hot chase we managed to apprehend driver of the said tractor namely Bipin Mahato (29) S/O Dharmaraj Mahato of Vill- Darda, PS- Jhalda, Dist- Purulia On asked, the driver disclosed his identity as mentioned earlier. On demand, he failed to produce any valid papers in respect of the Tractor which is attached with Trolley as well as loaded sand though sufficient time was given. During interrogation, the driver of said tractor confessed that he by illegal means for selling the same to make profit by dishonestly and he had been running a clandestine business. So it is reasoned to belief that he procured the said sand from Shyamnagar Ghat of Subarnarekha River by fraudulently means or theft by any means for transporting the same to run clandestine business. Ergo I, seized the vehicle 01 (one) tractor having reg. No- WB55A 6504 attached with sand loaded trolley (approx 100 cft sand loaded trolley) under proper seizure list in presence of available witnesses duly signed by them and arrested the driver of said tractor namely Bipin Mahato (29) S/O Dharmaraj Mahato of Vill- Darda, PS- Jhalda, Dist- Purulia under proper arrest memo and informed him the ground of arrest. Thereafter, I brought the said tractor to Jhalda PS compound.

Under the above facts and circumstances kindly take lawful action against the driver of the said vehicle as he committed offence U/S 379/411/414 of the IPC & 21 (4) Mines and Minerals (R&D) Act-1957.
