I, Shri Sekhar Kr, Mitra Inspr. of Police, DEB Purulia do here by lodged a complaint against following persons namely (1) Astam Kumar (55) S/o-Lt. Ghasiram Kumar (2) Ratan Kumar Pal (30) S/o-Astam Kumar (3) Alok Kumar Pal (28) S/o- Astam Kumar all of Vill-Bhatdih Taltol PS-Joypur Dist-Purulia along with following seized articles viz (1) PDS Atta 3,121 packets sealed condition, weighing 950 grams per packet, total weighing-2,956 Kg. marked as Laxmi Narayan food products, Reni road, Purulia mentioned on the packets which are contained in 77 Pcs plastic bag. (2) 08 packets PDS Wheat in sealed condition gunny bag marked Govt. of Hariyana & Punjab, total weighing-400 Kg. (3) 44 packets loose PDS Wheat weighing 1,405 Kg. (4) 02 packets PDS Rice in sealed condition weighing per packet 50 Kg Total-100 Kg. (5) 01 Pc Electronic weighing Scale machine (GF) (6) 12 Pcs Empty plastic bag to the effect that today on 21/01/2022 on the basis of secret and credible information I, Shri Sekhar Kr, Mitra Inspr. of Police, DEB Purulia along with SI Amaresh Das, ASI Swapan Chakraborty, C/88 Pradut Kumar Mondal,  ${
m HG/1427}$  Benimadhab Char all of DEB Purulia had been to the Joypur PS and submit a requisition to  ${
m I/C}$ Joypur PS for rendering assistance and noted the credible information at Joypur PS at 12:15 hrs vide Joypur PS GDE no. 943 dated 21/01/2022. Thereafter, ASI Nisith Chandra Das and force of Joypur PS and myself along with my team of DEB Purulia left for Bhatdih Taltol village under Joypur PS to work out the information by availing Govt. vehicle bearing No. WB 24AS 8059. On arrival at Bhatdih Taltol village to work out the information with two local people viz (1) Lakhindar Kumar S/o-Lt. Jagru Kumar (2) Amal Kumar S/o-Sadhu Kumar both of Bhatdih PS-Joypur Dist-Purulia to assist us for holding raid, search and seizure in the shop of Astam Kumar S/O- Lt. Ghasiram Kumar of Bhatdih Taltol village, PS-Joypur, Dist-Purulia. Thereafter myself along with accompanied officers and force and with the active assistance of above noted two local witnesses held raid in the shop of Astam Kumar after observing all formalities as laid down in Section 100 of Cr.PC 1973 relating to search & seizure. Prior to hold raid in the shop we noticed huge number of PDS Rice, Atta and wheat stocked inside the shop along with Electronic weighing Scale machine which is used for illegal selling. The shop owner Astam Kumar and his both sons asked to produced valid documents / license for running his business in respect of possessing PDS Rice, Atta and wheat but they failed to produce any valid documents/ license for running such illegal business. As such I seized the PDS items as mentioned in the seizure list in presence of local witnesses and Police witnesses under proper seizure list from the shop of Astam Kumar.

As Astam Kumar failed to produce any valid documents/ license for running such business, hence he violated provisions laid down in Para 7 of rule 3 of West Bengal. Thus Astam Kumar along with two sons namely (1) Ratan Kumar Pal (2) Alok Kumar Pal committed an offence punishable U/S- 7 (1)(a)(ii) of F.C (X) of Act 1955.

In course of local enquiry it revealed that said Astam Kumar and his both sons are running clandestine business of PDS goods since long without having any authority or license and selling it in black market only for causing his wrongful gain and deprived poor local consumers/customers as well as causing loss of revenue to the Govt.
