- 2. That the complainant planted mustard seeds upon his land bearing R.S. Plot No. 1840, khatian No.17, within Mouza_Tanasi, within p.s. Joypur_and the mustard plants have been grown up.. On 11.01.2022 at about 2.,30 P.M. when the complainant went to his land to look after the mustard plants,_suddenly the accused persons_namely Jamini Mahato,Sudhir Mahato,Manik Mahato,Gopal Mahato,Chepa Mahato,Nidhan Mahato, Khepa Mahato, Brindaban Mahato, Bulta Mahato, Dibakar Mahato, Magaram Mahato, Maheshwar Mahato, Jaleswar Mahato, Bholanath Mahato, Karna Mahato and Kumbha Mahato_by forming_unlawful assembly and armed with lathi, iron rode and tangi criminally trespassed into his land and damaged the mustard plants by uprooting the same. On being protest by the complainant, all the above-named accused persons gheroued him and accused Jamini Mahato, Sudhir Mahato pushed down him on the ground_then and there accused Manik_Mahato assaulted on his leg by the help of irone rode_as a result the complainant_has sustained injury on his leg. Thereafter the remaining accused persons namely Gopal Mahato, Chepa Mahato, Nidhan Mahato, Khepa Mahato, Brindaban Mahato, Bulta Mahato, Dibakar Mahato, Magaram Mahato, Maheswar Mahato, Jaleswar Mahato, Bholanath Mahato, Karna Mahato and Kumbha Mahato said to him "ake mere sesh kore de ". Shouted and hearing this the witness nos. 2 to 5 namely Malinda @Manindranath Mahato, Kartick Mahato, Bijoy Mahato, Nibaran Mahato and others co-vilagers came to the spot and they rescued him from further humiliation. Thereafter all the accused persons flee away. Due to damage the said mustard plants , the complainant has sustained a loss of Rs. 5,000/-.

3.That the complainant on the very day went to Joypur P.S.to lodge a complaint against the accused persons but they refused to receive the same ,then the complainant sent the written complaint to the O.C.Joypur P.S.trough registered post bearing postal receipt no.RW507422863 N dt.14.01.2022.bt/when the police did not take any action, the complainant then reported the matter in written to the Superintendant of Police but of no good.

It is ,therefore, prayed that your Honour be pleased to send this petition of complaint to the O/C, Joypur P.S. for investigation after treating the same as F.I.R. in under section 156(3) of Cr. P.C.
