

Sub: Request for lodging F.I.R. against arrested accused persons namely (1) Tarani Sen Bauri (49 years) S/O- Bhairab Nath Bauri of Salama, PS- Saltora, Dist - Bankura and 05(Five) others.

Sir,

In producing herewith 06 (Six) arrested accused persons namely (1) Tarani Sen Bauri (49 years) S/O-Bhairab Nath Bauri of Salma, PS- Saltora, Dist - Bankura (2) Sushanta Mandi(24 years), S/O- Ananda Mandi of Pochagora, PS- Kashipur, Dist.- Purulia (3) Laxmi Kanta Kisku(37 years) S/O- Sanatan Kisku of Kapista, PS Adra, Dist Purulia (4) Sadananda Dubey(40 years) S/O- Satyaban Dubey of Kapista, PS-Gangajal Ghati, Dist - Bankura (5) Ayub Ansary(60 Years), S/O- Lt. Soleman Ansary of Lara, PS-Kashipur, Dist.- Purulia (6)Srikanta Bauri, S/O- Nepal Ch. Bauri, Vill.- Toldih, PO- Rukni, PS-Raghunathpur, Dist.-Purulia

I beg to state that today (19.01.2022), I was directed to find out whether the guidelines of Govt. regarding pandemic situation has been implanted properly by Kashipur PS area or not vide Kashipur P.S CC No -190/22 Dtd 19.01.2022. Accordingly, I had been to Talajuri More under PS Kashipur at about 16.55 hrs and found that a gathering appeared at near Talajuri More none of them was wearing musk. On seeing Police party they have tried to escape from the grip of police party but they failed to escape due to efficiency effort of police party. On being asked he disclosed their identity as noted above.

They violated the order duly promulgated by government through public servants and through media etc for prevention of attack from CORONA Virus/COVID-19. They are creating annoyance to the society & violated govt. /order. Though in view of Pandemic of COVID-19 outbreak vide Govt. of India order No - 753/XX-ISS/2M-22/2020 dated - 15.01.2022 of the Government of West Bengal, Wearing of facial mask has been mandato; in public places in the current pandemic disaster situation, on violation of using mask and social distance norms should be strictly dealt with.

I arrested them for Disc bedience to order duly promulgated by public servant after maintaining all rules of arrest, Issued arrest Memo. I informed them & their relative regarding the ground of arrest i.e. as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). A prima facie there were sufficient evidences to secure their detention. All the process was done in between 17.05 hrs and 17.30 hrs on 19.01.2022. There was every chance of breach of peace and requiring of offence if not arrested.

Therefore, I pray a specific case may kindly be lodge against the above noted arrested aced. persons namely Tarani Sen Bauri (49 years) S/O- Bhairab Nath Bauri of Salama, PS- Saltora, Dist Bankura and 05(Five) others who were disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Quarantine rule U/S 188/34 IPC and Section 51(1) (b) National Disaster Management Act- 2005 and arrange for investigation.
