Mahato (29 Yrs), S/o- Upasi Mahato of Vill- Chatuhasa, PS- Arsha, Dist- Purulia (iii) Sibu Sahis (23 Yrs), S/o- Akash Sahis of Vill- Ashu Sahish Lane, Ward No-1 , PS- Purulia (T), Dist- Purulia (iv) Anil Murmu (37 Yrs), S/o- Chunaram Murmu of Vill- Koldih (Charandih), PS- Tamna, Dist-Purulia (v) Kanu Besra (30 Yrs), S/o- Mangal Besra of Vill- Lukuidih, PS- Kenda, Dist- Purulia (vi) Mithun Mandi (23 Yrs), S/o- Kalipada Mandi of Vill- Shasangora, PS- Kenda, Dist- Purulia (vii) Bajar Sarkar (21 Yrs), S/o- Subhas Sarkar of Vill- Jambaid, PS- Kenda, Dist- Purulia and (viii) Amar Mudi (34 Yrs), S/o- Jari Mudi of Vill- Mudidih (Sourang), PS- Kenda, Dist- Purulia do hereby lodge a written complaint against them to the effect that today on 07/01/2022, as per direction while I along with C/922 Sanjoy Bouri & NVF-239 Rabindra Mahato both of Kenda PS engaged in day mobile duty at Kenda PS area and while we reached at Kenda Bazar under Kenda PS at about 15:05 hrs. found that the above noted persons along with others moving here and there without wearing of mask during this pandemic situation and not maintaining the social distancing and on seeing the police parties some of them fled away and we are able to arrest the above noted accused persons, as there is every possibility that the above noted accused persons moving here and there without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of disease dangerous to human life and violated Government rule. I offered them for medical checkup, but they denied stating themselves ok, hence, I could not.

Therefore, I pray that a specific case may kindly be start against above noted arrested accused person as per proper section of law.
