With due respect and humble submission I beg to state that on 12/01/2022 at 17.35 hrs. ASI Uttam Gorain of Kenda PS produced 07 (seven) accused persons namely (i) Amrit Bouri (45Yrs.), S/o-Lt. Dibakar Bouri of Vill- Polmi, PS- Puncha, Dist- Purulia (ii) Bharat Ch. Mahata (39 Yrs), S/o- Lt. Guman Mahata of Vill- Tentlo, PS- Barabazar, Dist- Purulia (iii) Ranjit Paramanik (27 Yrs), S/o-Dwijapada Paramanik of Vill- Karraria, PS- Arsha, Dist- Purulia (iv) Tarapada Gope (28 Yrs), S/o-Kamal Gope of Vill- Telidih, PS- Tamna, Dist-Purulia (v) Manabendra Sahis (36 Yrs), S/o- Mihir Kr. Sahis of Vill- Bhutam, PS- Puncha, Dist- Purulia (vi) Mrityunjoy Sing Sardar (23 Yrs), S/o- Binod Sing Sardar of Vill- Kawatanga, PS- Boro, Dist- Purulia and (vii) Biplab Karmakar (21 Yrs), S/o- Tulshi Karmakar of Vill- Negurya, PS- Kenda, Dist- Purulia along with Memo of Arrest & other relevant papers and submitted a typed complaint against arrested accused persons, that on 12.01.2022 at about 16.35 hrs. while ASI Uttam Gorain along with force reached at Kenda Bazar in course of evening mobile duty found that a gathering appeared at Kenda Bazar and found above noted arrested accused persons were gossiping with others without wearing of mask and not maintaining the social distancing during this pandemic situation. So, there is every possibility that the above noted accused persons gossiping with others without wearing of mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of disease dangerous to life. Accordingly ASI Uttam Gorain arrested the above noted accused persons and also offered them for medical check-up, but they denied stating themselves ok, hence, he could not. Over this started Kenda P.S Case No - 06/2022 dtd. 12/01/2022 u/s- 188 /34 IPC and 51(1)(b) of Disaster Management Act, 2005 and endorsed to me for investigation.

During investigation of the case I interrogate the accused persons who confessed their guilt. One Mithun Paul, S/o- Ambuj Paul of Vill- Kenda, P.S- Kenda, Dist- Purulia stood surety of arrested accused persons. As the offence of accused persons is bailable so released the accused persons on bail after obtaining bail bond & PR bond of Rs. 1000/- on condition to produce the accused persons before Ld. CIM Sadar Court, Purulia on date fixed by the Ld. Court, failing which the accused and surety both are liable to pay fine to the state and shall come under the preview of law.

Under the above facts and circumstances, I pray before your kind honour that kindly accept their bail and oblige.
