

I, ASI Nimai Rajwar of Kenda PS, Dist- Purulia in producing herewith the following accused Persons namely (i) Rakhal Mahato (47Yrs.), S/o- Sitaram Mahato of Vill- Dhanara, PS- Arsha, Dist- Purulia (ii) Jhantu Mahato (31 Yrs), S/o- Niranjan Mahato of Vill- Rautora, PS- Barabazar, Dist- Purulia (iii) Shraban Mudi (30 Yrs), S/o- Lt.-Chhutu Mudi of Vill- Bishkudra, PS- Barabazar, Dist- Purulia (iv) Bikash Mudi (40 Yrs), S/o- Lt.-Santosh Mudi of Vill- Butgora, PS- Puncha, Dist- Purulia (v) Animesh Pati (39 Yrs), S/o- Dwijapada Pati of Vill- Rakhera, PS- Hura, Dist- Purulia (vi) Mangal Mahato (42 Yrs), S/o- Ambujaksha Mahato of Vill- Dakakendu, PS- Kenda, Dist- Purulia and (vii) Bishnu Pada Mahato (27 Yrs), S/o- Debu Mahato of Vill- Raghudih, PS- Kenda, Dist- Purulia do hereby lodge a written complaint against them to the effect that today on 19/01/2022, as per direction while I along with C/ 1345 Jitendranath Diasi & NVF-239 Rabindranath Mahato both of Kenda PS engaged in evening mobile duty at Kenda PS area and while we reached at Kenda Bazar under Kenda PS at about 16:05 hrs. found that the above noted persons along with others moving here and there without wearing of mask during this pandemic situation and not maintaining the social distancing and on seeing the police parties some of them fled away and we are able to arrest the above noted accused persons, as there is every possibility that the above noted accused persons moving here and there without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of disease dangerous to human life and violated Government rule. I offered them for medical checkup, but they denied stating themselves ok, hence, I could not.

Therefore, I pray that a specific case may kindly be start against above noted arrested accused person as per proper section of law.
