In producing here with the accused person namely Sunil Mura (40) s/o Prahalad Mura of vill.- Barametyala, PS-Kotshila, Dist-Purulia, brought under arrest along with seized articles as per seizure list i.e. one improvised country made fire arms (Iron made) length in total 27.5 cm (Approx) (Butt - 8 cm, Body - 5.5 cm & Barrel- 14 cm) having wooden butt, body, barrel, trigger, firing pin etc and 01 (One) round 8 mm live ammunition which has been seized from the exclusive possession of said Sunil Mura do hereby lodged a written complaint against the above noted arrested accused person to the effect that on 19/01/2022 at 14.05 hrs while myself along with C/983 Radhakanta Kisku, C/1524 Krishna Chandra Mahato (Kotshila PS GDE No. 700 dated 19/01/2022 & CC No. 161/22) both of Kotshila PS were engaged in Day mobile duty near Jabragora More Naka checking point on Purulia - Ranchi pitch Road (SH-4A) and found the above noted person was coming from Beradih village Side via Tatuara- Jabragora village pitch road towards Jabragora more by foot and on seeing the Police party he tried to fled away. Immediately my team chased him and apprehended him at Jabragora More. I asked him that why he tried to flee away. Then he made incoherent statement. I searched him on the spot and found one improvised country made fire arm loaded with one round live ammunition which was kept in left side of the waist concealed under the shirt of Sunil Mura. On demand he was unable to produce any valid documents /license in respect of keeping such arms & ammunitions, neither he can gave any satisfactory explanation in respect of carrying such arms ammunitions. It appeared he possessed those either to sell or to commit any crime. So I seized the said arms and ammunitions with proper seizure list and the seized arms and ammunitions packed, sealed and labeled in presence of police witnesses since none found there available to witness. The seizure was made in between 15.25 hrs and 15.55 hrs. Hence I arrested nim at 16:05 hrs as he has committed an offence which is punishable U/S- 25/27/35 of The Arms Act 1959.

Hence I pray to start specific case against arrested accused person namely Sunil Mura (40) s/o Prahalad Mura of vill.- Barametyala, PS-Kotshila, Dist-Purulia U/S Arms Act.
