In producing herewith 06 (Six) arrested accused persons 1) Sushen Ch Mahato (48 yrs) S/O- Lt. Budhu Mahato of Vill- Mahatomara, PS-Jhalda 2) Nirmal Mahato (47 yrs) S/O- Lt. Keshab Mahato of Vill- Mahatomara, PS-Jhalda 3) Sadhucharan Mahato (48 yrs) S/O- Rabi Mahato of Vill-Kalma, PS-Jhalda 4) Srimanta Mahato (26 yrs) S/O- Lt. Brindaban Mahato of Vill-Timangda, PS-Kotshila 5) Banamali Mahato (22 yrs) S/O- Faddari Mahato of Vill-Ulugariya, PS-Arsha 6) Swarup Mahato (20 yrs) S/O-Shantiram Mahato of Vill-Ulugariya, PS-Arsha, all of Dist- Purulia.

I beg to state that today (13.01.2022) evening at about 15.45 hrs I SI Purnendu Datta with C/2124 Sudip Pal and NVF-281 Santosh Singha Babu were performing evening patrolling duty at Kotshila Jiudaru School more and found the above noted persons were moving aimlessly without wearing mask at Kotshila Jiudaru School more. On seeing Police they tried to escape from the grip of police party but some of them failed to escape due to efficient effort of Police. On being asked, they disclosed their identity as noted above & they were loitering there without any purpose.

In this pandemic situation of CORONA Virus/COVID-19 the above noted persons violated the order duly promulgated by government and order vide memo no. 715-Home(Com)/RIM/(Com)-92/21 dated. 17.04.2021 of Govt. of West Bengal regarding any violation of masks and social distance norms should be strictly dealt with and memo no. 486-CS/2021 dated 24.04.2021 of Govt. of West Bengal & Order no- 753-ISS/2M-22/2020, Dt- 14/06/2021 & Order no- 753/II-ISS/2M-22/2020, Dt- 28/06/2021 & Order no- 753/III-ISS/2M-22/2020, Dt- 14/07/2021 & Order no-753/IV-ISS/2M-22/2020, Dt- 29/07/2021 & 753/XVII-ISS/2M-22/2020, Dt- 02.01.2022 So, I arrested them for disobedience of order duly promulgated by public servant. After maintaining all rules of arrest, issued memo of arrest. I informed them & their relatives regarding the ground of arrest i.e. as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). At prima facie there were sufficient evidences to secure their detention. All the process was done in between 16.15 hrs to 16.45 hrs. There was every chance of breach of peace and requiring of offence if not arrested.

Therefore, I pray to you that a specific case may kindly be lodged against the above noted accused persons as they disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to lives and violated the rule U/S 188/34 IPC and Section 51(1) (b) National Disaster Management Act- 2005 and arrange for investigation.
