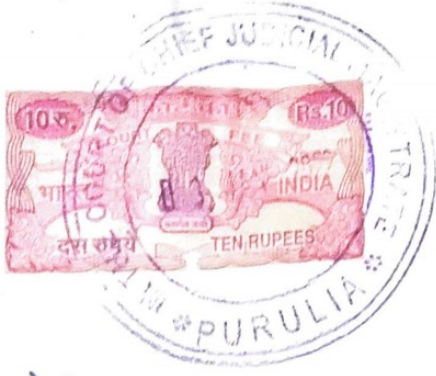

The above name complainant begs to state as follows:

- 1) That the complainant and the accused persons are the permanent resident of village, P.O. & P.S. Manbazar, Dist- Purulia.
- 2) That the complainant along with his friend namely Ardhendu Ghatak S/o Radha Raman Ghatak have purchased a piece of land which is situated at mouza Manbazar, R.S. khatian no. 1650, R.S. Plot no. 1084, area 53 decimals out of it 6 decimals and we have paid a sum of Rs. 8,50,000/- in all, more specifically they have paid 8,00,000/- for consideration money and also paid Rs. 50,000/- for miscellaneous purposes and accordingly they have paid a cash of Rs. 8,50,000/- to the above noted accused persons.
- 3) That it may be mentioned herein above that the said deed was executed and registered by the said Nanda Dulal Dutta and his son Sanjay Dutta in all along made conspiracy with his father when the said deed was executed and registered.
- 4) That it may be pertinent to point out that the complainant and his friend have another land to the adjacent back of the

mentioned above plot and they purchase the land for making roof and for ingress and egress towards the said land.

- 5) That meanwhile, the complainant and his friend started to make proposed roof at that time they have got informed that the father of Nanda Dulal Dutta namely Smbhunth Dutta sold the land prior to the execution and registration of the deed bearing no. 633 for the year 2021 and it was pertinent to point out that the said deed executed by Smbhunath Dutta is within the knowledge of Nanda Dulal Dutta and as a matter of fact Nanda Dulal Dutta is/ was the attesting witness of the said deed executed by his father, and in such circumstances it was well proved that Nanda Dulal Dutta has every knowledge that his father sold the property prior to execution and registration of the deed bearing no. 633 for the 2021 by accused Nanda Dulal Dutta.
- 6) The said accused Nanda Dulal Dutta knowing fully well that his father already sold the property, but he also again after receiving a sum of Rs. 8,50,000/- executed and registered the deed bearing no. 633 for the year 2021 with the

instigation and conspiracy of his son Sanjay Dutta. Accordingly both Nanda Dulal Dutta and Sanjay Dutta for their personal gain and loss to the complainant and his friend cheated them in the manner stated herein above, for which both Nanda Dulal Dutta and Sanjay Dutta are fully responsible and deserved to be punished under the law.

- 7) That when the complainant and his friend came to learnt about such cheating they requested the said accused Nanda Dulal Dutta and his son for returned back of the said amount with admissible interest or to execute and registered another deed within the same area of the land, but the above noted persons did not response to our request.
- 8) That the accused person committed various offences punishable under the Indian penal code for which he is deserved to be punished under the law.
- 9) That the matter was reported to the Officer-in-charge Manbazar P.S. against the accused persons but the said Officer-in-charge did not taken any legal action then the complainant lodged another complaint to the Superintendent
