Sir,

In producing here with 03 (Three) arrested accused persons namely (1) Mohibulla Bhuinya (26) S/O Ainurddin Bhuinya 2) Mojahid Khan (25), S/O Abdul Rahim Khan 3) Jakariya Khan (22) S/O Abdul Sukur Ali Khan all of village Dhuniagarh, PO- Rampur, PS – Indpur, District - Bankura along with seized motor Cycle, seizure list, arrest memos, Inspection Memos & other relevant papers.

I beg to state that today (31.12.2021), I was directed to find out whether the lock down has been implanted properly at Manbazar Market area or not. This refers to Manbazar PS GDE No- 1189, Dtd. 31.12.012. Accordingly, I had been to Indkuri more area at about 23:00 hrs and found that the above noted persons with their Motor Cycle having its Registration No - OD16/6465 were roaming aimlessly at Indkuri more area by rough and negligence driving. Myself along with force signed to stop him but driver of the Motorcycle drove speedily and disobedience of order. I detained them at near Indkuri morh on Purulia –Bankura road under Manbazar PS area after hot chasing. This rough and negligence driving would lead to an accident at any time. On being asked the above accused persons could not able to give any satisfactory answer for that movement on road and public place by such rough driving. Though lockdown is going on throughout the District of Purulia in view of pandemic of COIVD-19, so all the accused persons also doing negligently to spread infection of disease causing dangerous to human life in this pandemic situation.

So I arrested them for disobedience to order duly promulgated by public servant; after maintaining all rules of arrest, Issued memo of arrest & Inspection Memo. I informed them & their relatives regarding the ground of arrest. At prima facie there were sufficient evidences to secure their detention & arrest at this primary stage. More over they driven the motor cycle on public way in rush and negligently as to endanger to human life. On being asked they did not produce the valid documents in respect of said motor cycle as well as driving license at that time.

So I seized motor cycle bearing registration No- OD16/6465 (Model Hero splendor Pro, color Red) after preparing proper seizure list duly signed by the accused persons and witnesses. All the process was done in between 23.05 hrs and 23:25 hrs. There was every chance of breach of peace and requiring of offence if not arrested. As there was lock down in the town the peoples left the place and did not agreed to come forward to remain present as witness in the seizure process.

So a specific case may kindly be initiated against them as per law and arranged for its investigation. I handed over all the relevant papers, seizure list, seized motor cycles, Memo of arrest, Inspection Memo.
