**Subject :- Complaint Regarding Committing Theft of Iron Scrape From SIPL Plant
Boundary Wall near 350 DRI**

Respected Sir,

We would like to inform that on 02.01.2022 at around 06:30 PM, the guard on duty namely Mr Satendra Singh of M/S Champion Security posted at DRI 350 boundary wall has seen that one person namely Joydeb Tantubai, S/O Gurupada Tantubai, Address - BaruiPara, Puruliya Dist of M/S KS Bindra engaged as driver of Hywa (JH05 AC 2099) was throwing Iron scrapes outside the boundary wall. On seeing Guard, Joydeb Tantubai rode on the Hywa and driven away the vehicle. Guard has noted down the vehicle no.

Later on, with the help of vehicle number, Joydeb Tantubai was captured by our Security Officers from the Plant premise and also Security Officers have recovered the scrape materials (four pieces of Iron scrapes having gross weight of around 100 Kgs) from outside the boundary wall. Subsequently, Joydeb Tantubai along with recovered materials is handed over to Police Station for onward action.

Your good Office is requested to lodge complaint against Joydeb Tantubai and take appropriate action at your end. Your urgent and proper action is solicited so that recurrence of such activity is prevented in the plant.
