Sir,

In producing herewith 05 (Five) arrested accused persons namely (1) Raja Thakur (19) S/O- Pradip Thakur of Vill-Parbelia Bazar, PS-Neturia, Dist-Purulia (2) Madhusudan Chattaraj (24) S/O- Manik Chattaraj of Vill-Hijuli, PS-Neturia, Dist-Purulia (3) Rajesh Ghosh (32) S/O- Madhab Ghosh of Vill-Nabagram, PS-Neturia, Dist-Purulia (4) Madhab Mandal (23) S/O- Jiban Mandal of Vill-Benipur, PS-Neturia, Dist-Purulia and (5) Akash Mallick (25) S/O- Montu Mallick of Vill-Sanctoria Colony, PS-Kulti, Dist-Paschim Burdwan do hereby lodge a written complaint against the above noted accused persons to the effect that today on 03.01.2022 while I, SI Biswajit Banerjee, along with C/1361 Munshi Kamal Hassan, C/564 Prasad Majhi and C/399 Kartik Chandra Mura all are of Neturia PS as per direction engaged in evening mobile duty in Neturia PS area, reference Neturia PS GDE No- 128 dated 03.01.2022 for implementation of Government rules regarding lockdown Disaster Management Plan. While we reached at Parbelia Bazar at about 19:35 hrs found that the above noted persons were gathered there without any valid reason and without wearing mask which violates the compliance of norms of Government order as well as wearing of mask during this pandemic situation. I asked them about their presence at Parbelia Bazar but they failed to give any satisfactory answer. So, they violated the compliance of norms of Government order as well as wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188/34 IPC & 51 (1) (b) of National Disaster Management Act, 2005. Accordingly, I arrested the above noted accused persons after maintaining all formalities regarding arrest as they committed cognizable offence in presence of police.

Therefore, I pray a specific case may kindly be started against the above noted accused persons U/S- 188/34 IPC & 51 (1) (b) of National Disaster Management Act, 2005 and arrange for its investigation.
