Sir,

Mangal Bauri of Vill-Sarbari, PS-Neturia, Dist-Purulia (3) Sk. Kurban (28) S/O- Lt. Sk. Jamshed of Vill-Namodigha, PS-Neturia, Dist-Purulia (4) Kuddush Khan (51) S/O- Lt. Jugal Majhi of Vill-Gopalpur, PO-Chorpahari, PS-Raghunathpur, Dist-Purulia do hereby lodge a written complaint against the above noted accused persons to the effect that today on 08.01.2022 while I, SI Abhijit Das, along with C/1319 Soumen Koley, C/174 Tapandas Bauri and NVF/660 Ranjit Kumabhakar all are of Neturia PS as per direction engaged in mobile duty in Neturia PS area, reference Neturia PS GDE No- 374 dated 08.01.2022 for implementation of Government rules regarding lockdown Disaster Management Plan vide Order No- 753/XVII-ISS/2M-22/2020 Date: 02.01.2022. While we reached at Sarbari More at about 15:55 hrs and found that the above noted persons were gathered there without any valid reason and without wearing mask which violates the compliance of norms of Government order as well as wearing of mask during this pandemic situation. I asked them about their presence at Sarbari More but they failed to give any satisfactory answer. So, they violated the compliance of norms of Government order as well as wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188/34 IPC & 51 (1) (b) of National Disaster Management Act, 2005. Accordingly, I arrested the above noted accused persons after maintaining all formalities regarding arrest as they committed cognizable offence in presence of police.

Therefore, I pray a specific case may kindly be started against the above noted accused persons U/S- 188/34 IPC & 51 (1) (b) of National Disaster Management Act, 2005 and arrange for its investigation.
