Sir,

In producing herewith 09 (Nine) arrested accused persons namely (1) Mithu Bauri (30) S/O- Lt. Gonesh Bauri of Vill-Parbelia Gram, PS-Neturia, Dist-Purulia (2) Bivas Majee (21) S/O- Narayan Chandra Majee of Vill-Bonra, PS-Neturia, Dist-Purulia (3) Khare Majhi (36) S/O- Hari Majhi of Salanpur, PS-Salanpur, Dist-Paschim Burdwan, A/P- C/O- Sohan Majhi of Dishergarh 6 No., PS-Kulti, Dist-Paschim Burdwan (4) Subir Bauri (30) S/O- Buchga Bauri of Vill-Saltore Saloni Para, PS-Neturia, Dist-Purulia (5) Sanjoy Bistu (34) S/O- Lt. Jiten Bistu of Vill-Kuthibari (Near Hanuman Mandir), PS-Neturia, Dist-Purulia (6) Ajay Mandi (28) S/O- Lt. Ruplal Mandi of Vill-Tiltore, PO-Digha, PS-Neturia, Dist-Purulia (7) Sukanta Tudu (22) S/O- Sukdeb Tudu of Vill-Kapasdanga, PS-Santuri, Dist-Purulia (8) Dathu Hansda (36) S/O- Lt. Some Hansda of Vill-Malatidhowra, PO-Sundarchak, PS-Kulti, Dist-Paschim Burdwan and (9) Jhulan Bauri (24) S/O- Naran Bauri of Barui Para Sarbari, PS-Neturia, Dist-Purulia do hereby lodge a written complaint against the above noted accused persons to the effect that today on 08.01.2022 while I, SI Biswajit Banerjee, along with C/1319 Soumen Koley, C/174 Tapandas Bauri and C/660 Ranjit Kumbhakar all are of Neturia PS as per direction engaged in Naka duty near Sarbari More, reference Neturia PS GDE No- 416 dated 08.01.2022 for implementation of Government rules regarding lockdown Disaster Management Plan vide Order No- 753/XVII-ISS/2M-22/2020 Date: 02.01.2022. We started Naka checking duty near Sarbari More at about 22:15 hrs and found that the above noted persons moving by vehicles through Purulia - Barakar road without any valid reason and without wearing mask which violates the compliance of norms of Government order i.e. movement of people or vehicle in between 10:00 PM to 05:00 AM during this pandemic situation. I asked them about their movement but they failed to give any satisfactory answer. So, they violated the compliance of norms of Government order as well as wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188/34 IPC & 51 (1) (b) of National Disaster Management Act, 2005. Accordingly, I arrested the above noted accused persons after maintaining all formalities regarding arrest as they committed cognizable offence in presence of police.

Therefore, I pray a specific case may kindly be started against the above noted accused persons U/S- 188/34 IPC & 51 (1) (b) of National Disaster Management Act, 2005 and arrange for its investigation.
