Saw (30) S/O- Sri Kailash Saw of Vill- Amdanga, Parbelia Colliery, PS-Neturia, Dist-Purulia, do hereby lodge a written complaint against the above noted accused persons to the effect that today on 09.01.2022 while I, SI Banshi Lal Mahato, along with C/939 Laltu Paul, C/680 Biswanath Roy and C/1568 Debjyoti Sinha all are of Neturia PS as per direction engaged in mobile duty in Neturia PS area, reference Neturia PS GDE No- 439 dated 09.01.2022 for implementation of Government rules regarding lockdown Disaster Management Plan vide Order No- 753/XVII-ISS/2M-22/2020 Date: 02.01.2022. While we reached at Parbelia Bazar at about 15:45 hrs and found that the above noted persons were gathered there without any valid reason and without wearing mask which violates the compliance of norms of Government order as well as wearing of mask during this pandemic situation. I asked them about their presence at Parbelia Bazar but they failed to give any satisfactory answer. So, they violated the compliance of norms of Government order as well as wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188/34 IPC & 51 (1) (b) of National Disaster Management Act, 2005. Accordingly, I arrested the above noted accused persons after maintaining all formalities regarding arrest as they committed cognizable offence in presence of police.

Therefore, I pray a specific case may kindly be started against the above noted accused persons U/S- 188/34 IPC & 51 (1) (b) of National Disaster Management Act, 2005 and arrange for its investigation.
