Sub: Complain to start a specific case.

Sir,

In producing herewith one arrested accused person namely Sk. Sare Alam (26) S/O- Sk. Jakir of Vill-Murulia, PS-Santuri, Dist-Purulia (Driver of tractor) along with seized Tractor with trolley without registration Number having Engine No- J23596, Chassis No- 926513159010 (Model – 380 Eicher Tractor) loaded with raw coal of 02 MT (approx) do hereby lodge a complaint to the effect that today on (23/01/2022) I, SI Biswajit Banerjee, along with C/1361 Munshi Kamal Hassan, C/1568 Debjyoti Sinha and C/680 Biswanath Roy all of Neturia PS were engaged in evening mobile duty vide Neturia PS GDE No-1094 Dt. 23.01.22 & CC No- 277/22 Dt. 23.01.22. In course of Mobile Duty, at about 18:15 hrs when we reached at Gobag More, I received an credible source information to the effect that one Tractor without registration number loaded with illegal coal coming from Rangdih village side and will transport the same to Raghunathpur side in clandestine manner as per their regular practice. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately started to move towards Rangdih village side through Purulia - Barakar pitch road. At about 18.35 hrs we reached at Bhasko More beside Purulia - Barakar pitch road under Neturia PS and found one tractor was coming from Rangdih village side. We indicated the vehicle to stop and on checking it was found that coal seems to be steam was loaded inside of the tractor. Then I requested the driver to produce relevant documents/challan/cash memo in respect of loaded coal but he failed to produce any valid documents in support of loaded coal as well as vehicle. On preliminary enquiry and as per statement of the restrained driver it could be learnt that he along with registered owner of the tractor have procured said coal from different illegal coal mines at different area at Murulia village side under Santuri PS.

So, it is reasonable to believe that the above noted accused driver and registered owner of the said tractor have obtained the said coal either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same coal in a clandestine manner to Raghunathpur side knowing it to be stolen.

Accordingly, I seized Tractor with trolley without registration Number having Engine No- J23596, Chassis No- 926513159010 (Model – 380 Eicher Tractor) loaded with steam coal of 02 MT (approx) under proper seizure list duly signed by available witnesses and also I arrested Sk. Sare Alam (26) S/O- Sk. Jakir of Vill-Murulia, PS-Santuri, Dist-Purulia (Driver) in this case. In course of arrest I notified him ground of arrest, issued arrest memo U/S-50 Cr PC and brought him PS with loaded tractor with trolley. I have also sealed & labelled approx 05 (Five) kg coal as sample from the seized tractor on the spot.

Under the above circumstances, a specific case may kindly be started against 1) Sk. Sare Alam (26) S/O- Sk. Jakir of Vill-Murulia, PS-Santuri, Dist-Purulia (Driver of tractor) and (2) Owner of seized tractor having Engine No- J23596, Chassis No- 926513159010 under proper section of law.
