Sir.

In producing herewith one arrested accused person namely Kanchan Modak (20 Year) S/O- Baban Modak of Vill-Mangalda, PS-Raghunathpur, Dist-Purulia, A/P- Rented house of Dhanu Mukherjee of Dishergarh, Near Sanctoria Jr. High School, PS-Kulti, Dist-Paschim Burdwan (Driver) along with seized vehicle having registration Number WB 02J/8159 (Maruti Suzuki Omni) loaded with raw coal of 02 Quintal (approx) do hereby lodge a complaint to the effect that today on (27/01/2022) I, SI Abhijit Das, along with C/564 Prasad Majhi, C/1550 Bharat Ghosh and C/1568 Debjyoti Sinha all of Neturia PS were engaged in evening mobile duty vide Neturia PS GDE No- 1295 Dt. 27.01.22 & CC No- 333/22 Dt. 27.01.22. In course of Mobile Duty, at about 18:30 hrs when we reached at Saltore area, I received an credible source information to the effect that one Maruti having registration number WB 02J/8159 loaded with illegal coal coming from Dishergarh Side and will transport the same to Raghunathpur side in clandestine manner. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately started to move towards Rahul Hotel side on Purulia - Barakar pitch road. We reached near Rahul Hotel beside Purulia - Barakar pitch road under Neturia PS at about 18.45 hrs and started Naka checking there. At about 19.25 hrs found one Maruti was coming from Dishergarh side. We indicated the vehicle to stop and on checking it was found that coal seems to be steam was loaded inside the vehicle. Then I requested the driver to produce relevant documents/challan/cash memo in respect of loaded coal but he failed to produce any valid documents in support of loaded coal as well as vehicle. On being asked he disclosed his identity as noted above and on preliminary enquiry and as per statement of the restrained driver it could be learnt that he along with registered owner of the vehicle have procured said coal from different illegal coal mines at different area.

So, it is reasonable to believe that the above noted accused driver and registered owner of the said vehicle have obtained the said coal either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same coal in a clandestine manner to Raghunathpur side knowing it to be stolen.

Accordingly, I seized the vehicle having registration Number WB 02J/8159 (Maruti Suzuki Omni) loaded with raw coal of 02 Quintal (approx) under proper seizure list duly signed by available witnesses and also I arrested Kanchan Modak (20 Year) S/C- Baban Modak of Vill-Mangalda, PS-Raghunathpur, Dist-Purulia, A/P- Rented house of Dhanu Mukherjee of Dishergarh, Near Sanctoria Jr. High School, PS-Kulti, Dist-Paschim Burdwan (Driver) in this case. In course of arrest I notified him ground of arrest, issued arrest memo U/S-50 Cr PC and brought him PS with loaded vehicle. I have also sealed & labelled approx 03 (Three) kg coal as sample from the seized vehicle on the spot.

Under the above circumstances, a specific case may kindly be started against 1) Kanchan Modak (20 Year) S/O- Baban Modak of Vill-Mangalda, PS-Raghunathpur, Dist-Purulia, A/P- Rented house of Dhanu Mukherjee of Dishergarh, Near Sanctoria Jr. High School, PS-Kulti, Dist-Paschim Burdwan (Driver) and (2) Owner of seized vehicle having registration No- WB 02J/8159 under proper section of law.
