Sir,

In producing herewith 12 (Twelve) arrested accused persons namely (1) Sanat Bauri (43) S/O- Lt. Ramasish Shaw of Vill- Amdanga, PS-Neturia, Dist-Purulia do hereby lodge a written complaint against the above noted accused persons to the effect that today on 06.01.2022 while I, SI Manas Dutta, along with C/564 Prasad Majhi and C/805 Narayan Chandra Dhibar all are of Neturia PS as per direction engaged in Naka duty near Neturia PS, reference Neturia PS GDE No- 298 dated 06.01.2022 for implementation of Government rules regarding lockdown Disaster Management Plan vide Order No- 753/XVII-ISS/2M-22/2020 Date: 02.01.2022. We started Naka checking duty near Neturia PS at about 22:05 hrs and found that the above noted persons moving by vehicles through Purulia - Barakar road without any valid reason and without wearing mask which violates the compliance of norms of Government order i.e. movement of people or vehicle in between 10:00 PM to 05:00 AM during this pandemic situation. I asked them about their movement but they failed to give any satisfactory answer. So, they violated the compliance of norms of Government order as well as wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188/34 IPC & 51 (1) (b) of National Disaster Management Act, 2005. Accordingly, I arrested the above noted accused persons after maintaining all formalities regarding arrest as they committed cognizable offence in presence of police.

Therefore, I pray a specific case may kindly be started against the above noted accused persons U/S- 188/34 IPC & 51 (1) (b) of National Disaster Management Act, 2005 and arrange for its investigation.
