Sub: Request for lodging F.I.R. against arrested accused person Abdul Shakeel S/O - Abdul Wakil of Vill.- + P.O- Chandaha, P.S-Sialjori, Dist- Bokaro (JH).

Sir,

In producing herewith arrested accused person namely Abdul Shakeel S/O- Abdul Wakil of Vill + P.O- Chandaha, P.S-Sialjori, Dist-. Bokaro (JH) along with seized one Black and Blue Hero HF- Deluxe bearing reg. No. JH09AG/7054. I beg to report that today myself along with C/935 Sahadeb Majee, 2) C/1407 Susanta Goswami and 3) NVF/867 Sankar Ch. Dey all of Para PS were performing evening mobile duty by Govt. vehicle heading towards Rukni more under Para PS area vide Para PS Misc C.C No- 152 dtd 16.01.2022 and Para PS GDE No- 578 dtd. 16.01.2022. At about 18.15 hrs, I found at Dubra bazaar near Durga Mandir one Black and Blue Hero HF- Deluxe bearing reg. No. JH-09AG/7054 coming from Rukni side rashly and negligently. We tried to stop him but the driver of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. On demand he failed to produce his driving license and valid paper in support of said motorcycle.

So, I arrested him as he violated sec 279 IPC and 181/184 M.V Act. at 18.25 hrs. I also seized the vehicle with a view to prosecute him U/S 279 IPC and 181/184 M.V Act. in presence of witnesses. The whole process of seizure was completed in between 18.30 hrs to 18.45 hrs. His family member was also informed about the ground of arrest.

Hence I pray that a specific case U/S 279 IPC and 181/184 M.V Act. may kindly be initiated against Abdul Shakeel S/O- Abdul Wakil of Vill + P.O- Chandaha, P.S- Sialjori, Dist-. Bokaro (JH).
