

- 2) That, Ghaltu Mahato was the son of your Complainant

The Police was informed and the Police came and recovered the dead body of Ghaltu Mahato from the pond and sent it for Post Mortem Examination and thereafter Police did nothing no rexamined your Complainant nor his family members nor the Witnesses though there is strong prima-facie Case against the above noted Accused person and others and if proper investigation is done the truth will come to light and your Complainant is confirmed that the accused Bhadu Rani Mahato and her associates are responsible for the commission of the murder of your Complain-nant's son.

7) That, your Complainant waited for the Police of the Concluding Nas. P. pww.ha.who.war Liferagen 15.1221 action and investigation till date but all in vain and your Complainant became mentally puzzled and shocked and that is why could not ledge Complaint in time.
