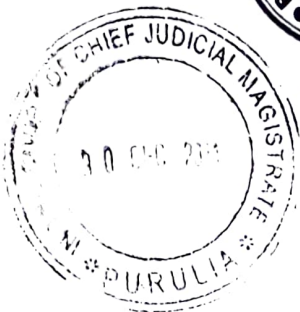

- 2) That, Ghaltu Mahato was the son of your Complainant
- 3) That, the accused Bhadu Rani Mahato wife of Gopal Mahato of Vill. & P.O.- Chirka, P.S.- Purulia(M), Dist.- Purulia, came to the house of your Complainant on 12/09/2021 at about 6 P.M. and called Ghaltu Mahato, then ~~for~~ Ghaltu Mahato left the house with Bhadu Rani Mahato.

- 4) That, since the leaving of the house of your Complainant the mobile phone of Ghaltu Mahato was switched off though your Complainant tried to contact Ghaltu Mahato several times ^{but} ~~and~~ no fruitful result came out and all in _^ [^] vain.
- 5) That, your Complainant tried to search out his son Ghaltu Mahato through out the night but could not be traced out.
- 6) That, on 13/09/2021 the dead body of Ghaltu Mahato

was traced out in the pond namely "Bura Bandh" of Village - Chirka. The Police was informed and the Police came and recovered the dead body of Ghaltu Mahate from the pond and sent it for Post Mortem Examination and thereafter Police did nothing nor examined your Complainant nor his family members nor the Witnesses though there is strong prima-facie case against the above noted Accused person and others and if proper investigation is done the truth will come to light and your Complainant is confirmed that the accused Bhadu Rani Mahato and her associates are responsible for the commission of the murder of your Complainant's son.

7) That, your Complainant waited for the Police action and investigation till date but all in vain and your Complainant became mentally puzzled and shocked and that is why could not lodge Complaint in time.

It is therefore prayed that your Honour be pleased to send this Petition of Complainant to the O/C. Purulia(M) P.S. for investigation after treating the same as P.I.R. in U/S. 156(3) Cr.P.C. for the ends of Justice.
