In producing herewith the 06 (six) persons namely 1) Dhiren Kalindi (35 yrs) s/o Ghaltu Kalindi of Vill-Chargali, PS- Purulia (M), Dist-Purulia (2) Manbodh Kalindi (24 yrs) s/o Manik Kalindi of Vill-Sitalpur, PS- Purulia (M), Dist-Purulia (3) Dipak Mahato (23 yrs) s/o Nirod Mahato of Vill-Manakchita, PS- Joypur, Dist- Purulia (4) Uttam Soren (25 yrs) s/o Bamkesh Soren of Vill- Durgi, PS- Jhalda, Dist- Purulia (5) Ramesh Soren (24 yrs) s/o Narayan Soren of Vill- Damrughutu, PS- Kotshila, Dist- Purulia (6) Manik Gorain (45 yrs) s/o Ram Gorain of Vill-Bhul, PS- Purulia (M), Dist- Purulia.

The fact of the case in a nut shell is that I SI Abhijit Singha along with force namely (i) C/497 Ambuj Kr. Mandal & ii) C/321 Tulsidas Roy was performing the Special Mobile duty for the implementation of Complete Lock Down under Purulia (M) PS area vide Purulia (M) PS GDE No 789 dtd. 18.01.2022 in consonance with C.C No 210/2022 Dtd. 18.01.2022 as per order of superior. During my Special Mobile Duty, while I arrived near at Adhikari Hotel on Purulia-Bankura Road at 22:35 hrs. and found 06 (six) persons noted in the supra were confabulating among themselves sitting beside the road without wearing the mask and maintaining the social distance at the partial lock down in all over the state. On being asked they could not give sufficient reason or satisfactory answer of their unwarranted confabulation beside the road after violating the Government order in this pandemic situation. Consequently, it reasoned to believe that they violated the order and disobeyed the direction during this pandemic situation duly promulgated by in consonance with order promulgated by Govt. of West Bengal vide Memo No 753/XX-ISS/2M-22/2020 dtd. 15.01.2022 following with the order of Govt. of West Bengal vide Memo No-753/XVII-ISS/2M-22/2020 dtd. 02.01.2022. Consequently, the supra noted persons were arrested on the spot and informed them the ground of their arrest and issued memo of arrest in respect of them.

As the supra noted persons violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 753/XX-ISS/2M-22/2020 dtd. 15.01.2022 in consonance with order promulgated by Govt. of West Bengal vide Memo No 753/XVII-ISS/2M-22/2020 dtd. 02.01.2022 following with the order of Govt. of West Bengal vide Memo No-753/XX-ISS/2M-22/2020 dtd. 15.01.2022 so they can be booked U/S 188/34 of the IPC and 51 of National Disaster Management Act. 2005. So a specific case may kindly be initiated against them and arranged for its investigation.
