
In the matter of an Application u/s 156 (3) Cr.P.C.

The Complainant named above begs to state as follows:-

- That the Complainant is the legally married husband of the Accused no-1 and their marriage has been solemnised on 12/12/2018 as per the Mohameddan laws of marriage and customs. The Accused no- 2 to 6 happens to be the parental family members of the Accused no-1
- 2) That after the marriage, the Complainant and the Accused no-1 started living as husband and wife at the house of the Complainant. Since after the marriage, the Accused no-1 often used to go to her parental house without the consent of the Complainant and often used to stay there on various false pleas. Subsequently the Accused no-1 started residing at her father's house by avoiding the company of the Complainant. For the very reason a dispute has been arisen between the Complaint and the Accused no-1. On several times the Complainant requested the Accused no-1 to return to his house but the Accused no-1 clearly showed her innorance to the Complainant by saying that she would not return to his house. The Accused no-1 over telephone directed to the Complainant to stay in her parental house as Ghor Jamai against which the Complainant raised his objection and strongly denied to do the same.








3) That subsequently on 27/04/2021, at about 6 p.m. when the Complainant was in his house, all on sudden all the Accused Persons entered into the house of the Complainant and started abusing him with filthy languages. They started to pressurize the Complainant to stay at the parental house of the Complainant as Ghor Jamai and also started to threaten him with dire consequences. The Complainant raised his strong objection and also denied to stay as Ghor Jamai. Icating his denial, all the Accused Persons forcibly tried to take the Complainant ith them to their house. Hearing noise, the witnesses no-2 to 5 reached at the ouse of the Complainant and tried to settle the matter. But all the Accused Persons started to abuse them also with filthy languages. The Complainant protested against the illegal activities of the Accused Persons and for the very reason, all the Accused Persons started to assault the Complainant mercilessly with fists, blows and kicks and also threatened to kill him and the result of which the Complainant sustained several injury on his person and also fell on the ground. They also broken the house hold articles of the Complainant. They also snatched the mobile phone of the Complainant of Rs.12,000/- and also snatched Rs.5000/- from the Complainant. At that time the Accused no-6 assaulted the Complainant mercilessly by pressing his throat. The Complainant anyhow managed to save himself with the help of the family members of the Complainant. At that time, some of the neighbours also rushed to the spot and seeing them to come to the spot, the Accused Persons fled away from the spot. At that time also the Accused Persons threatened the Complainant and his family members of dire consequences.

- 4) That after the incident, the Complainant immediately went to the Purulia(M) P.S along with some of his family members and also informed about the matter and also filed a Written Complaint in that respect. Accordingly the Police Personal at the P.S. who was on duty at the relevant time assured him that they will take appropriate step against the Accused Persons.
- 5) That the Complainant subsequently went to Deben Mahato Govt. Medical College and Hospital, Purulia for treatment. Thereafter the Complainant on several occasions visited the concerned P.S but the concerned police office started to drag the matter on various false pleas and pretexts. After waiting a considerable period, as no step was taken by the Police, the Complainant sent his Written Complaint to the Purulia(M)P.S. through Registered Post on 06/12/2021 which was delivered to concerned P.S.







6) That when the Complainant found that the police of Purulia(M)P.S. practically has not taken any step whatsoever against the Accused Persons, the Complainant on 13/12/2021 submitted a Written Complaint before the Superintendent of Police, Purulia but even in spite of all these endeavours of the Complainant, no step has been taken by the police and as such the Complainant is being compelled to lodge this Petition u/s 156(3) Cr.P.C. before Your Honour's Court.

That the Complainant being a helpless, poor and rustic villager is unable to surrange for producing the Witnesses in Court at his own cost. Moreover in the instant case various documents as well as medical papers of the injured are to be seized which could not be possible without police help.

It is therefore prayed that Your Honour may be graciously pleased to send this Complaint to the I.C Purulia(M)P.S. with a direction to treat the same as FIR and to start the investigation in the matter and to prosecute the Accused Persons as per law.
