I SI Aloke Chattaraj (46 yrs) S/O Nirmal Chattaraj presently posted at Purulia (M) PS under your kind control, would like to draw your kind attention regarding the incident that on 27.01.2022 while myself accompany to assist ASI Partha Sarathi Murmu along with force of Purulia (M) PS, vide GDE No 1200 dtd. 27.01.2022 at 20:25 hrs left PS for holding raid at Harialgara village under Purulia (M) PS to secure arrest FIR named accused person namely Bulet Roy S/O Biswa Roy of Vill-Harialgara, PS- Purulia (M), Dist- Purulia in c/w Purulia (M) PS Case No 54/2021 Dtd. 10.03.2021 U/S 341/324/325/427/379 of the IPC as several attempts were made to serve notice u/s 41 (A) Cr.P.C. as per norms but he was avoiding to receive the notice intentionally. As per order of I/C Purulia (M) PS. While myself along with above noted force arrived at Harialgara village at about 23:30 hrs and holding raid at respective house FIR named accused person. During the arrest of said FIR named accused Bulet Roy on that time some local villagers under the direct leadership of (i) Bishwa Roy S/O Lt. Ghaltu Roy who is a convict now is on parole instigated and provoked the following persons namely (ii) Sunil Roy S/O Ghaltu Roy, (iii) Mutuka Roy W/O Sunil Roy, (iv) Sundara Roy W/O Bulet Roy, (v) Belu Roy S/O Bishwa Roy, (vi) Jothsna Roy W/O Belu Roy, (vii) Adalat Roy S/O Lt. Akuri Roy (viii) Bulet Roy S/O Biswa Roy and (approx.) 20 others of Roy family of said villagers obstructed me for serving Govt. duty and also assaulted our police team with bamboo and bricks and pelting stone thereby damaged our Govt. vehicle having Reg. No WB24AM-7921. As a result we are received injury and I could not able to secure arrest the FIR named accused person Bulet Roy. Lastly we returned to PS from Harialgara village after medically treated at Purulia Sadar Hospital.
