Dear Sir

I, Partha Manna am the office Accountant of Mahindra and Mahindra Financial Services Limited Purulia Branch. On 1st January 2022, our cashier Biswarup Dey handed over the cash of Rs.355464/- (500*6, 200*1) to our office assistant Mr. Mintu Dey for depositing the cash to HDFC BANK . But at the time of banking, he deposited the cash in bank 3 bundle (500*2, 200*1) and loose note in a lot. Hence, there is a deficiency of Rs. 200000/- (500*4) which was missing from bag. Our office assistant told me that in the by lane near our office building at around 10.45 am to 11.00 am three person with a bike came towards me and told me that they are police personal and have to check his bag for security reason. After that the office assistant handedover the bag and they are searching something and after few minutes they returned back that bag to our office assistant. And he went to the bank for depositing the cash. After going to the bank when he deposited the cash to the cashier then cashier found that 2 lakh rupees is short according to the PIS copy. Then cashier of HDFC bank informed Mintu Dey and he called our branch cashier Biswarup Dey and told him everything about cash shortage. We believe that the missing Rs.200000/- was stolen by those three unknown person who had checked the bag.

You are therefore requested to kindly investigate the matter .
