Sir,

In producing herewith the accused persons namely (1) Sourav Chakraborty (23 y/M), S/O- Ashim chakraborty of Huchuk Para, near Victoria School down, ward no-05, PS-Purulia (T), Dist-Purulia (2) Biswajit Mahato (24 y/M), S/O- Santosh Mahato Of Vill- Digshili, PO- Chakaltore, PS- Tamna, Dist-Purulia to the effect that on 07.01.2022 while I PSI Suvajit Nandi and force (1) NVF/188 Arup Kr.Mahato and HG 1454/ Prakash Char both of Purulia(T) PS, Dist-Purulia were performing Special Drive against non wearing mask vide Purulia(T) PS GDE No- 326, Dated- 07.01.2022. During my mobile duty when myself along with force reached at Hat tala more under Purulia (T) PS at 13:05 hrs and found the above persons were roaming aimlessly at Hat Tala More without mask. But when I tried to detain them they obstructed me in discharge of my duty by using criminal force and pushed me while I was in full uniform with proper identity. With the help of another assisting officer ASI Maloy sarkar, C/2962 Ujjal Mahanti , HG/1574 Swapan Mahato and other forces I managed to detain them. On being asked the above noted persons disclosed their identity but they could not able to give any satisfactory answer for their movement on road and public place without wearing mask violating Govt Order. So, I arrested them as per the procedure laid down in Cr. P.C and followed the latest guidelines of the Apex Court, prepared arrest memo. I also offered them medical aids, but they refused. So having no other alternate way, I brought them to PS and put them in lockup maintaining all legal formalities.

As the pandemic period related to COVID-19 is going on and hence to prevent its mass spreading the Central Govt. & the State Govt. has passed an order to wear mask in the public place is mandatory and ordered to prosecute the defaulters. They violated the order duly promulgated by the government through public servants and through media etc for prevention of spreading of CORONA Virus/COVID-19. They were creating annoyance to the society & violated the govt. order. Though in view of Pandemic of COVID-19 outbreak vide Govt. of India order No- 753/XVII-ISS/2M-22/2020 dated 02.01.2022 of the Government of West Bengal, wearing of facial mask has been mandatory in public places in the current pandemic disaster situation. Whereas, vide advisory issued vide no- 715-Home (Cons)/RIM(Cons)-92/2021dated- 17.04.21, Government of West Bengal and other advisories issued time to time has stressed that any violation of mask and social distance norms should be strictly dealt with.

Hence I pray before you to start a specific case against the above noted persons under proper section of law.
