

Bauri of Vill+PO- Siholi, PS- Purulia(M), Dist.- Purulia, to the effect that on 09.01.2022 while I SI Jayanta Maji and force (1) C/2345 Debsankar Barik and (2) C/2041 Uttam Man both of Purulia(I) PS, Dist Purulia were performing Special Drive against non wearing mask vide Purulia(T) PS GDE No- 456, Dated-09.01.2022. During my mobile duty when myself along with force reached at Taxi Stand under Purulia (1) PS at 22:15 hrs and found the above persons were roaming aimlessly at Taxi Stand without mask. I started to detain them. On being asked the above noted persons disclosed their identity but they could not able to give any satisfactory answer for their movement on road and public place without wearing mask. So, I arrested them as per the procedure laid down in Cr. P.C and followed the latest guidelines of the Apex Court, prepared arrest memo. I also offered them medical aids, but they refused. I also offered them bail, but no sureties turned up. So having no other alternate way, I brought them to PS and put them in lockup maintaining all legal formalities.

As the pandemic period related to COVID-19 is going on and hence to prevent its mass spreading the Central Govt. & the State Govt. has passed an order to wear mask in the public place is mandatory and ordered to prosecute the defaulters. They violated the order duly promulgated by the government through public servants and through media etc for prevention of spreading of CORONA Virus/COVID-19. They were creating annoyance to the society & violated the govt. order. Though in view of Pandemic of COVID-19 outbreak vide Govt. of India order No- 753/XVII-ISS/2M-22/2020 dated 02.01.2022 of the Government of West Bengal, Wearing of facial mask has been mandatory in public places in the current pandemic disaster situation. Whereas, vide advisory issued vide no- 715-Home (Cons)/RIM(Cons)-92/2021dated- 17.04.21, Government of West Bengal and other advisories issued time to time has stressed that any violation of mask and social distance norms should be strictly dealt with.

Hence I pray before you to start a specific case against the above noted persons under proper section of law.
