I, Guddu Prajapati, son of kameshwer Prajapati, is staff of Om Sharda Logistics Pvt Ltd. and taking care of our company's contract job at RTPS-DVC and hereby inform you that Mukesh Kumar alias Raju Tiwary (Pan No AEHPK5261N) whom I don't even have any previous contact is giving threatening to me over different mobiles since last month to do away with life, if I stand hurdle in his work. I even don't know his work. Even he offered me bribe for giving him illegal favour in our transporting business but I didn't agree, All in a sudden Mukesh Kumar along with his 8-9 goons in a black Scorpio dashed to my company office om sharda logistics pvt ltd, on 24-12-2021 at Salanchi and beat me and my colleague Baleshwar yadav son of Komal yadav pulling us out of our office, and have given me tremendous pressure for taking bribes to give him illicit favour, but when I disagree, then he throttled my neck to take away my life then we shouted to save our life, our more staff came out to save us, then they threatened this is only warning, mend your way, or else I will kill you. At 8:30 am

Consequently to his beating, I developed acute pains in my head and chest that was not cured by taking medicine. Later on, treated myself immediately before doctor, I was in trauma and took rest and thus delay in lodging complaint.
