Sub: Complaint against the dumper, numbered WB37C 9699, carrying unauthorized sand, with rash driving, to be treated as F.I.R.

Sir.

A dumper, numbered WB37C 9699, owned by Kanailal Maji, as per the initial information, being had from the driver, related herewith (Phone No. 9064158092, written on the dumper), carrying more than at least 500 cft of sand, without any legal document and/or without any official permission, as well, to carry the said sand, was, as per a particular source of prior particulars, first spotted nearby the Office of the undersigned at 4.45PM, today, i.e., on 11/01/2022.

However, the driver, named Bhushan Bauri, S/O Ramu Bauri, did not stop for approximately next 4 kms, which, because of his rash driving, might have caused an accident.

Ultimately, at the Mouza of Seleta, across the Cheliyama Road, Raghunathpur, the said dumper was caught by the raid team, concerned, led by the undersigned. The driver could not show any challan to justify the carriage of that unauthorized sand. In this regard, the undersigned, U/S 21 of M.M.D.R. Act, sends this letter to your good Office, to treat this serious complaint as an F.I.R.

The dumper, loaded with illegal sand, the key of the dumper, and a file, containing few papers, supposedly related to the dumper are being handed over, to do the needful, as per the law.
