





1. That the complainant is a permanent resident of village:Kankibazar, PS: Santaldih, Dist: Purulia under the jurisdiction
of this Ld.court. All accused persons are the co-resident of
same village.

- 2. That needless to say the accd. persons are very much enimical to the complainant and all time trying to do mischief with the person of the complainant in order to fulfill their ill-motive with their high handed action. Since accd. persons are very much influenceal for their muscle power.
- 3. That on the day of occurrence at relevant point of time a marriage procession party was passing through the village of Kuli road in front complainant's house and mistakenly procession party was parking their vehicle's in front of the house of the Complainant in Which complainant requested the provession party to let it remove from their front just to avoid completion of ingress and egress in which procession party remove their vehicl -e but the accd. persons taking such issue because furious to take revenge of previous grudge gathered in front house of the complainant and started ramsackled as well as abuseing with filthy language in which complainant raised protest but the accd. persons grow furious and left the complainant house while with threat and came with arm like asraful with iron rod and Tazimuddin with Axe, Nur Ansary with iron rod and other accd. persons with lathi entered into the house of the complainant wit h a view to cause griveous injury on his persona and loudly asked the complainant to face them .Even accd. persons also used alang abusive language towards mother of complainant with ugly gesture intending to outrage her modesty shouting" unwwerthe words and languages.



Be it noted the complainant anyhow saved himself and his mother for the time being from the clutches of accd. persons However the accd. persons left the house of complainant by giving out threat they will finish the life of the complainant on opportunate moment.

- 4. That such illegal & desperate act of accd. persons complainant sustained mental trauma.
- 5. That the corplainant reported the matter to the O/C Santaldih P.S. on the same day, we such no action had been taken by police authority hence complainant sent his grievious to the S.P. Purulia through Regd. post on 30-11-21 but till date no step has been taken from that end.
- 6. That finding no other alternative complainant seeks his reme-

It is therefore prayed that an order may kindly be passed upon I/C Santaldih to came investigation into the matter treating this an F.I.R. as per section 156(3)Cr P.C., shall ever pray.
