

Sir,

In producing herewith one seized vehicle i.e. bearing Reg. Number-WB 81/0080, Mahindra DLX & having Engine No- NFNB01481 and Chassis No. NFNB01481 fitted with Trolley (without number plate) loaded with coal. The fact of the case in brief is that I, SI Montaz Sheikh along with force were on special mobile duty vide Santuri P.S C.C. No. 17/2022 dtd. 02/01.2022. At about 15:05 hrs received one credible source information that the above noted (Tractor) is loaded coal at brick factory of Sk. Tazim at Murulia village under Santuri PS. After receiving this information we were proceeding towards brick factory of Sk. Tazim at Murulia village to work out the information. When we reached at brick factory of Sk. Tazim at Murulia village, found that one tractor loaded with coal Approx 03 MT and seeing police party the driver of the said vehicle fled away after keeping the tractor at brick factory. We searched the said tractor and found that the registration No. of the tractor is WB 81/0080, Mahindra DLX & having Engine No-NFNB01481 and Chassis No. NFNB01481, tractor is loaded with coal. I searched for any valid documents in respect of loaded coal in the tractor as well as the valid documents in respect of that tractor but nothing found So, I have seized the said tractor under proper seizure list. I have also sealed & labeled approx 01 (one) K.G coal as sample from the major contraband. There was no such public witness available at the time of seizure. Thereafter arranging a public driver I brought the seized tractor loaded with coal at Santuri P.S compound as such there is every reason to believe that the owner of brick factory Sk. Tazim, driver and owner of the said Tractor with have procured the coal from illegal coal pit to run a clandestine business without any valid document in support of carrying coal. So they are liable for offence punishable U/S 379/411/413/414 IPC & R/W Sec. 30(2) of CMIN Act 1973.

I therefore pray before you to lodge a specific case against the owner of brick factory Sk. Tazim, driver and owner of the said Tractor bearing Registration No. WB 81/0080, Mahindra DLX & having Engine No- NFNB01481 and Chassis No. NFNB01481
