Santosh Bauri, Vill.- Maraldih, (4) Gouri Shankar Char (42 Yrs), S/O- Sambhunath Char, Vill- Manpur, (5) Bulbul Hari (42 yrs), S/O - Rakshakar Hari , Vill--Garshika all are PS-Santuri, Dist- Purulia & do hereby lodge a written complaint against them, to the effect that today on 11,01.2022 while I along with force of Santuri PS as per direction engaged in Special mobile duty within Santuri PS area, (Reference Santuri P.S G.D.E No.386 dtd. 11.01.2022) for implementation of Government rules regarding Disaster Management Plan. On 11.01.2022 while we returning from Marbedia side under Santuri P.S jurisdiction and reached at Santuri Morh through Saltora-Raghunathpur Road at about 22:15 hrs. found that the above noted 05 (Five) persons were gossiping near Santuri Morh without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation in c/w COVID-19.
