Respected Sir,

I, Mrinmay Bhakta, PSI of Police, Santuri PS, Dist. – Purulia do hereby produce (1) Pravas Das (31 yrs), S/O – Lt. Fatik Das (2) Subhas Das (48 yrs), S/O- Lt. Fatik Das both are Vill.– Ledium, (3) Rajesh Bauri (35 yrs), S/O – Lt. Santosh Bauri, Vill.– Maraldih, (4) Gouri Shankar Char (42 Yrs), S/O- Sambhunath Char, Vill- Manpur, (5) Bulbul Hari (42 yrs), S/O – Rakshakar Hari, Vill-- Garshika all are PS-Santuri, Dist- Purulia & do hereby lodge a written complaint against them, to the effect that today on 11.01.2022 while I along with force of Santuri PS as per direction engaged in Special mobile duty within Santuri PS area, (Reference Santuri P.S G.D.E No.386 dtd. 11.01.2022) for implementation of Government rules regarding Disaster Management Plan. On 11.01.2022 while we returning from Marbedia side under Santuri P.S jurisdiction and reached at Santuri Morh through Saltora-Raghunathpur Road at about 22:15 hrs. found that the above noted 05 (Five) persons were gossiping near Santuri Morh without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule (Memo No. 753/XVII-ISS/2M-22/2020 Dated- 02nd January 2022 Government of West Bengal 'Nabanna' 325, Sarat Chatterjee Road Howrah- 711102). So, I have arrested them maintaining all legal formalities as well as notifying the ground of arrest and informed their family members through local people.

Therefore, I pray a specific case may kindly be started against accused persons (1) Pravas Das (31 yrs), S/O – Lt. Fatik Das (2) Subhas Das (48 yrs), S/O- Lt. Fatik Das both are Vill.– Ledium, (3) Rajesh Bauri (35 yrs), S/O – Lt. Santosh Bauri, Vill.– Maraldih, (4) Gouri Shankar Char (42 Yrs), S/O- Sambhunath Char, Vill- Manpur, (5) Bulbul Hari (42 yrs), S/O – Rakshakar Hari, Vill-- Garshika all are PS-Santuri, Dist- Purulia under proper sec. of law as they disobeyed/ignored Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
