I, SI Badal Paramanik, of Tamna PS, Dist- Purulia, do hereby produce (1) Dwushashan Mahato @ Lara (27 Yrs) S/O- Deben Mahato of Vill- Pandrama, PS- Tamna, Dist- Purulia, (2) Prasenjit Gorain (22 Yrs.) S/O- Bhaddeswar Gorain at Mission Road, Purulia, Word No-5, PS- Purulia (T) PS, Dist- Purulia A/P- Vill- Raherdih, PO- Kantadih, PS- Arsha, Dist- Purulia, (3) Indra Ruhidas (21 Yrs.) Rajkishore Mahato, of Vill- Simulia Bhairabdi, PS- Tamna, Dist- Purulia, and lodge a written complaint against them, to the effect that on 08.01.2022 while myself along with force of Tamna PS as per direction engaged in PS Evening Mobile duty within Tamna PS area, (Reference Tamna P.S G.D.E No. 343 dtd. 08.01.2022) for implementation of Government rules of Disaster Management Plan reached at Simulia More under PS-Tamna at about night 22:05 hrs. on 08.01.2022 and found that the above noted 05(Five) persons were gossiping without wearing mask and not maintaining physical distancing which violates the compliance of norms of wearing of mask and maintaining physical distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving without wearing mask and not maintaining physical distancing which violates the compliance of norms of Govt. of India as well as Govt. of West Bengal during this pandemic situation and committed negligent act likely to spread infection of diseases which dangerous to life. So, I have arrested them maintaining all legal formalities as well as notifying the ground of their arrest.

Therefore, I pray a specific case may kindly be started against accused (1) Dwushashan Mahato @ Lara (27 Yrs) S/O- Deben Mahato of Vill- Pandrama, PS- Tamna, Dist- Purulia, (2) Prasenjit Gorain (22 Yrs.) S/O- Bhaddeswar Gorain at Mission Road, Purulia, Word No-5, PS- Purulia (T) PS, Dist- Purulia A/P- Vill- Raherdih, PO- Kantadih, PS- Arsha, Dist- Purulia, (3) Indra Ruhidas (21 Yrs.) S/O- Shraban Ruhidas of Vill- Palma, PO- Palma Panchara, PS- Kenda, Dist- Purulia, (4) Ramesh Rajwar (35 Yrs.), S/O- Nibaran Rajwar of Vill- Simulia Natundih, PS- Tamna, Dist- Purulia, (5) Mathur Ch.
