Sir,

I, SI Bikash Chandra Patra S/O- Lt. Ananda Mohan Patra of Tamna PS, Dist- Purulia, do hereby produce (1) Soumya Banerjee (32 yrs) S/O- Sukhendu Banerjee of Dulmi –Nadiha, Chirabari, Ward no. 07, PS- Purulia(T), Dist- Purulia, (2) Abhijit Sen (35 yrs) S/O- Prasanta Sen of Dulmi Down (Shib Mandir Gali), PS- Tamna, Dist- Purulia, (3) Mantulal Majhi (41 yrs) S/O- Lt. Karim of Vill- Tentlo, PO- Bhul, PS- Purulia (M), Dist- Purulia & (7) Nilkamal Mahato (20 Yrs) S/O- Satrughan Mahato of Vill- Sonajuri, P.O- Baligara, PS- Tamna, Dist- Purulia and lodge a written complaint against them, to the effect that on 17.01.2022 while myself along with force of Tamna PS as per direction engaged in Special Night mobile duty within Tamna PS area, (Reference Tamna P.S G.D.E No. 710 dtd. 17.01.2022) for implementation of Government rules of Disaster Management Plan reached at Dulmi in front of Hotel Hillview at about 22:15 hrs and found that the above noted 07 (Seven) persons were gossiping without wearing mask and not maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving without wearing mask and not maintaining social distancing which violates the compliance of norms of Govt. of India as well as Govt. of West Bengal during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life. So, I have arrested them maintaining all legal formalities as well as notifying the ground of their arrest.

Chatulal Majhi of Vill- Aralkhocha, PS- Arsha, Dist- Purulia, (4) Bimal Chatterjee (25 yrs) S/O- Jagajjyoti Chatterjee of Vill- Nimbard, Ward No. 05, PS- Purulia(T), Dist- Purulia, (5) Satyajit Mudi (20 yrs) S/O- Anil Mudi of Vill- Kukurgeriya Satar, PO- Kukurgeriya, PS- Purulia(M), Dist- Purulia, (6) Sk.
