Harendranath Kaibarta of Vill- Chakaltore, PS- Tamna, Dist- Purulia, (4) Bimal Bhuiya (55 yrs) S/O-Lt. Shibaram Bhuiya of Vill- Tara, PS- Tamna, Dist- Purulia & (5) Buddheswar Sing Sardar (21 yrs) S/O- Samar Sig Sardar of Vill- Tamna, PS- Tamna, Dist- Purulia, under proper section of law as they ignored the norms of Govt. of India as well as Govt. of West Bengal and committed negligent Act. likely to spread infection of diseases dangerous to life and arranged for its investigation.
