


Sub: Complaint to start a specific case.

Sir,

I, SI Badal Paramanik S/O- Lt. Nirmal Ch. Paramanik of Tamna PS, Dist- Purulia, do hereby produce (1) Chintu Mudi (32 yrs) S/O- Surya Mudi of Vill- Digshili, PS- Tamna, Dist- Purulia, (2) Sk. Tufan (36 yrs) S/O- Sk. Raju at Purulia Taldanga, Ward No- 08, PS- Purulia (M), Dist- Purulia, (3) Dukhu Mandi (29 yrs) S/O- Badyanath Mandi of Vill- Rajakhanda, PS- Kenda, Dist- Purulia, (4) Satyajit Rajak (19 yrs) S/O- Ashok Kr. Rajak of Vill- Bانشرا, PS- Tamna, Dist- Purulia, (5) Maheswar Rajwar (32 yrs) S/O- Bhutu Rajwar of Vill- Durku, PS- Tamna, Dist- Purulia, (6) Nagar Das (28 yrs) S/O- Lt. Chakradhar Mahato of Vill- Simulia, PS- Tamna, Dist- Purulia, and lodge a written complaint against them, to the effect that on 28.01.2022 while myself along with force of Tamna PS as per direction engaged in Special Night mobile duty within Tamna PS area, (Reference Tamna P.S G.D.E No. 1211 dtd. 28.01.2022) for implementation of Government rules of Disaster Management Plan reached at Simulia more on 29.01.2022 at about 02:55 hrs and found that the above noted 07 (Seven) persons were gossiping without wearing mask and not maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving without wearing mask and not maintaining social distancing which violates the compliance of norms of Govt. of India as well as Govt. of West Bengal during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life. So, I have arrested them maintaining all legal formalities as well as notifying the ground of their arrest.

Raju at Purulia Taldanga, Ward No- 08, PS- Purulia (M), Dist- Purulia, (3) Dukhu Mandi (29 yrs) S/O- Badyanath Mandi of Vill- Rajakhanda, PS- Kenda, Dist- Purulia, (4) Satyajit Rajak (19 yrs) S/O- Ashok Kr. Rajak of Vill- Bانشرا, PS- Tamna, Dist- Purulia, (5) Maheswar Rajwar (32 yrs) S/O- Bhutu Rajwar of Vill- Durku, PS- Tamna, Dist- Purulia, (6) Nagar Das (28 yrs) S/O- Lt. Mantusta Das of Vill- Durku, PS- Tamna, Dist- Purulia, & (7) Subodh Ch. Mahato (48 yrs) S/O- Lt.
