In producing herewith one arrested accused person namely Nepal Bauri (59 yrs) S/O- Lt. Satrughna Bauri of Vill- Damda, P.S- Tamna, Dist.- Purulia with seizure list and seized articles, I beg to submit that today i.e on 04.01.2022 at about 06:05 hrs during special mobile duty, received a secret source information and as per order of O/C Tamna PS, I PSI Surajit Kr. Das of Tamna PS along with force had been to Damda village under Tamna PS at 06:35 hrs and as per indication conducted raid in the house of Nepal Bauri (59 yrs) S/O- Lt.
