Dadan Chowdhury of Palashkola, PS-Adra, Dist- Purulia to the effect that on 01/02/22 at about 14:45 hrs I received a information from a reliable source that one Lachman Chowdhury has been stock of country spirit illegally at his tea stall at Palashkola near Upkar Club. After getting such information I informed to my I/C and as per his direction I along with my accompanied force left Adra PS vide Adra PS CC No-300/22 dtd.01.02.22. I reached at Palashkola near Upkar Club at about 15:15 hrs and hold raid in the tea stall at Palashkola near Upkar Club of said Lachman Chowdhury and found that the said person selling liquor at his tea stall at Palashkola near Upkar Club and after seeing the Police party some person fled away and said Lachman Chowdhury has tried to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing /selling the same.
