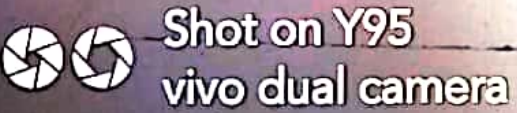

Sir,

In producing here with one arrested accused namely Ranjit Chakraborty (44 Yrs) S/O Lt. Bibhuti Chakraborty of Beniasol Adra, PS-Adra, Dist-Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 16 bottles DIL KHUSH country spirit, 600 Ml. each Rs/-50 of each bottle.

I SI Simanta Tantubai of Adra PS do here by lodged a complaint against accused namely Ranjit Chakraborty (44 Yrs) S/O Lt. Bibhuti Chakraborty of Beniasol Adra, PS-Adra, Dist-Purulia to the effect that on today 18/02/2022 in course of evening patrolling duty as per order vide Adra PS CC No-676/22 dtd.18.02.22. I received a information from a reliable source at about 16:15 hrs that one Ranjit Chakraborty is selling country spirit illegally at Mukhtadal Club More Adra. After getting such information I informed to I/C Adra P.s over telephone and as per his direction I along with accompanied force reached at Mukhtadal Club More Adra at about 16:35 hrs and held raid at Mukhtadal Club More Adra and found that the above noted accd. Person selling country spirit at his Jhupri and after seeing the Police party, all the person fled away and said Ranjit Chakraborty has tried to conceal himself but we able to apprehend him. I asked him to produced valid License or valid papers in respect of selling of country spirit but he failed to produce any valid license or documents in respect possessing /selling the same. So it is sufficient reason to believe that above said Ranjit Chakraborty engaged to sale the country spirit by illegal way. So I seized the above mentioned country spirit under proper seizure list duly sign by accused person and available witnesses I also collect sample from seized country spirit duly sealed and labeled by me. There after I arrest the above mentioned accused person with informing him the ground of arrest. The complete process was done in between 16.45 hrs to 17.25hrs.

I there for pray that a specific case may kindly be start against arrested accused Ranjit Chakraborty (44 Yrs) S/O Lt. Bibhuti Chakraborty of Beniasol Adra, PS-Adra, Dist-Purulia under proper section of law.
